EXPORT CONTROL LAWS

Cryptomathic has a general export license. We export goods under the Danish License, (Export Control Compliance Programme), Serial No. DK01113/01 issued by the Danish Agency for Trade and Industry, Denmark. This allows us to export our existing products to all countries except Iran, Iraq, Libya, Syria and North Korea.

GOVERNING LAW AND JURISDICTION

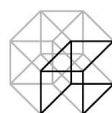
